The candidates are allowed to make the corrections, latest by **14 March 2023** (up to 9:00 P.M.). Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through **Credit/Debit Card/Net Banking/UPI** (upto 11:50 P.M.) on 14 March 2023.

Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are advised to do the correction very carefully, as no further opportunity for correction will be given to the candidates.
