
**AMENDMENT NOTIFICATION**

Reference is invited to this Ministry's Notification of even number dated 06.05.2022 vide which JEE apex Board (JAB) was re-constituted for JEE (Main) and JEE (Advanced) Entrance examinations for the year 2022 & 2023.

2. Consequent to completion of the term of previously constituted JEE Apex Board (JAB), it has been decided by the competent authority to re-constitute the JEE Apex Board (JAB) for smooth conduct of both JEE (Main) and JEE (Advanced) Entrance Examination for the year 2024 & 2025, with the following composition: -

JAB may invite a nominee of President/ Council of Architecture or Director of any SPA as special invitee to the meeting.

### 3. Term of Reference

- i. The JAB would have a permanent secretariat which would be provided by National testing Agency (NTA). JAB would be assisted by the JEE Interface Group comprising of five members drawn from NTA, IITs and a senior representative of Indian Statistical Institutes (ISI) nominated by the Joint Apex Board.
- ii. The JAB will be the final authority for setting up the policies, rules, regulations for the conduct of JEE (Main). It will also coordinate with JEE (Advanced) organizing institution. The Secretariat will be responsible for serving the Apex Board as well other groups created by JAB for the purpose. It will also be responsible for Administration, finance, Court Case, RTI etc.
- iii. NTA will provide the administrative and logistic support for the conduct of JEE (Main) across the country. The permanent secretariat of the JAB, housed in the NTA, will use the existing infrastructure, surplus of financial resources accumulated since creation of the first JAB and the manpower being contributed by the present JEE (Main) unit, with a small number of posts created as per Cabinet/ CEE approval, if required, including that of the executive Director, based on actual requirement.
- iv. The JAB of the IIT system (JAB-IIT) shall continue to assume responsibility for the conduct of the JEE (Advanced).
- v. The NIC / C-DAC will help in all information technology related (software) support and back-end activities for pre and post-examination work, including on-line submission of application forms.
4. The transparency processes established by the IIT system in JEE (Main) and JEE (Advanced) shall be adopted.
5. This issues with the approval of Hon'ble Education Minister.
